

**Assistant Professor
California State University, Sacramento
Hospitality and Tourism Management**

The Department of Recreation, Parks & Tourism Administration at California State University, Sacramento, is seeking applications for a probationary, tenure-track appointment at the Assistant Professor rank in the area of Hospitality and Tourism Management. This appointment is to begin fall 2018. Priority Review of applications will begin October 13, 2017; position open until filled.

Education: Ph.D. (or comparable degree). At a minimum, an applicant must have at least one degree at the master's or doctoral level in Hospitality, Tourism, or a closely related field. Individuals who are verified ABD at the time of application, will be considered. Evidence must be given that the degree will be finished within one year of appointment.

Additional Requirements: Applicants should show evidence of having the equivalent of at least two years full-time experience (or the equivalent in part-time employment) working in the hospitality or a closely related field within the last ten years*. Applicants should demonstrate teaching experience related to the subject matter, with preference given to applicants that can also teach in the department core and/or the university General Education program. Applicants should demonstrate a strong ability to work with professional organizations and/or businesses.

It should be noted that this is not a position for a recreation generalist, or a tourism theorist lacking knowledge of and experience in the hospitality industry. Applicants are advised to read the full vacancy announcement.

*A candidate with less industry experience may be considered if the applicant can show evidence of extensive teaching, student advising, and course development in the area of hospitality and/or tourism management.

Application Procedures:

Candidates must include the following attachments with the application:

- a. Cover letter (that can include a statement of teaching philosophy and scholarly interests)
- b. Current curriculum vita/resume
- c. Recent professional references (3 - 5): names and contact information
- d. Unofficial transcripts attesting to highest degree earned and all degrees relevant to the subject matter of the position being applied for (*Note: Official transcripts can be submitted later but certainly before a candidate is invited to campus for interview.*)
- e. A scholarly writing sample (need not have been published), relevant to areas of teaching
